ORDER AMENDING THE REGULATIONS FOR QUALITY ASSURANCE IN TENURE-TRACK PROCEDURES AT THE PADERBORN UNIVERSITY [TENURE-TRACK REGULATIONS]

**Regulations amending the Regulations for quality assurance in tenure-track procedures at Paderborn University
(Tenure Track Regulations)**

of 10 November 2023

On the basis of §§ 2 para. 4 sentence 1, 38a of the Higher Education Act of the State of North Rhine-Westphalia (Higher Education Act - HG) of 16 September 2014 (GV. NRW. p. 547), last amended by Act of 29 August 2023 (GV. NRW. p. 1072), the Senate of Paderborn University has adopted the following amendment to the Regulations for Quality Assurance in Tenure-Track Procedures at Paderborn University (Tenure-Track Regulations):

Article I

The Regulations on Quality Assurance in Tenure Track Procedures at Paderborn University (Tenure Track Regulations), issued on 30 November 2018 and published in the Official Notices of Paderborn University No. 67.18 of 30 November 2018, are amended as follows:

1. § 2 is revised as follows:

§ 2 Scope of application

¹On the basis of the Law on Universities of the State of North Rhine-Westphalia (HG) and the Basic Regulations of Paderborn University, these regulations govern the procedure for filling positions for junior professorships with tenure track and all fixed-term professorships with tenure track at Paderborn University. ²In addition, the regulations for the appointment of Professorships and Junior Professorships at Paderborn University (Appointment Regulations).

2. § 3 (3) shall be reworded as follows:

¹The tenure-track professorship shall in principle be advertised in accordance with Sections 38 and 38a of the NRW Higher Education Act. ²As a rule, the vacancy shall be advertised internationally. ³It may initially only be awarded for a fixed term; this must be indicated in the advertisement. ⁴It must also be pointed out that a tenure commitment is made which is not subject to a job reservation.

3. § 3 (4) shall be reworded as follows:

¹The Faculty Council shall determine the evaluation criteria together with the application for the call for applications or establishment. ²These can also be determined by the appointment committee (tenure committee see § 6).

4. § 3 (8) is amended as follows:

Paragraph 8 is deleted.

Articel II

These amendments shall enter into force on the day following their publication in the Official Notices of the Paderborn University come into force.
